The General Policy and Finance Committee of Council met at 7:10 p.m. on Monday, April 27th, 2020. - A. An ordinance for Municipal Authority board member salary increase from \$100 to \$200 was discussed. Mr. Moury gave a brief summary on the background of the salaries. Dr. Campbell raised the concern that he didn't think it was a good time to pass this ordinance and suggested that it be pushed off until September-October. Council agreed and this will be tabled for now until September-October.
- B. 2020 Real Estate resolution that if a resident pays their 2020 real estate taxes by 12/31 that no penalty or interest will be assessed. It was agreed upon that this will be passed at the May 11<sup>th</sup> regular meeting.
- C. Purchase of Microsoft Surface Pro iPads for Council agenda meetings. Mrs. Gibbons asked why there was a range and price and it was explained that depending on the space and capability is the reason for the price range. Mr. McLean asked if this needed to be bid and since it's under state contract that it wouldn't be necessary. Mr. Harrison asked if the IPADS have the capability to be projected on the wall for everyone to see if necessary and if they would be able to take them home or if needed to leave them at the building for the next meeting. The manager noted that the iPads do have the capability to be projected to a larger screen if necessary and that Council members would be able to take them home and be able to bring them back for the next meeting.
