RE: Public Works and Maintenance Committee Meeting

The Public Works and Maintenance Committee of Council met on Monday, February 28, 2022. Present (in person and remotely) were Council Members: Campbell (R), Cenci, Consolmagno, Espinar, Flinn, Janosik, Moury, Oakes, O'Brien and Mayor Allen. Also in attendance was Stacey Graf, Drew Dowdell, Adam Steele(R), Lisa Lapaglia(R), and Kirsten Primm

The following items were discussed:

- 1. 988 Fairview Drive Storm Sewer Installation This item will be placed on the March 14, 2022 agenda for consideration.
- 2. 2022 Road Projects
 - a. Rejuvenator Staff recommends acceptance of the low bid of \$124,950.00 from Pavement Technology, Inc. at the March 14 Regular Council meeting.
 - b. Landscaping Staff recommends acceptance of the low bid of \$39,600.00 from Telegraphis Landscape LLC at the March 14 Regular Council meeting.
 - c. Road Paving Staff recommends acceptance of the low bid of \$1,541,553.45 from Youngblood Paving, Inc. for the combined Base Bid, Alternate #1, and Alternate #2 at the March 14 Regular council meeting.

Council did have some discussion on awarding to the lowest bidder. Council requested that Tucker provide a brief summary of awarding requirements.

- 3. 2022 Storm Sewer Projects
 - a. Staff recommends acceptance of the low bid of \$377,265.00 from Roto-Rooter Services for the 2022 Storm Sewer Repair Project at the March 14 Regular Council meeting.
 - b. Staff recommends acceptance of the low bid of \$196,176.00 from Robinson Pipe Cleaning Company for the 2022 Storm Sewer CCTV & Cleaning Project at the March 14 Regular Council meeting.
- 4. 2022 Sanitary Sewer Projects
 - a. Recommend that Council award the 2022 Manhole Rehabilitation Project to State Pipe Services in the amount of \$73,600.00 at the March 14 Council Meeting.
 - b. Recommend that Council award the 2022 Sanitary Sewer Lining Project to Jet Jack, Inc in the amount of \$353,900.00 at the March 14 Council Meeting.
 - c. Recommend that Council award the 2022 Sanitary Sewer Excavation Project to Roto-Rooter in the amount of \$63,265.00 at the March 14 Council Meeting.
 - d. Recommend that Council award the 2022 Sanitary Sewer CCTV and Manhole Inspection Project to Robinson Pipe Cleaning Project in the amount of \$217,175.00 at the March 14 Council Meeting.

- 5. PNC Bank Kiosk/Brixmor Property Council would like to wait until after the site visit on March 8, 2022 to determine a direction.
- 6. Brightwood Road Traffic Calming Improvements Council would like to have Option 1 installed and look in to the implementation of the three additional recommendations
- 7. Baptist at Hamilton Road Intersection Improvement Project/ARLE Grant Council would like to move forward with the design of the project. Council understands that additional funds will be required.
- 8. Pickleball Court Council will move the project to 2023 and additional grants will be applied for over 2022 grant cycle. Staff should finalize the design plans and be ready to bid.
- 9. Pine Tree Park Playground /Budget Discussion & Request to Bid Council agreed to allocate \$48,000 to the project and to allow staff to bid the sidewalk installation.
- 10. Splash Pad Project Update Council would like to hold off on the project until RACP Grant approval is received. Staff should have plans and specifications finalized, so the project can move ahead as soon as grant approval is received. At the March 28th meeting, Council will discuss the sponsorship and fundraising opportunities.
- 11. 5110 W. Library Avenue Property Acquisition No discussion on this item.
- 12. Montour Avenue Property No discussion on this item.
- 13. Sidewalk Policy Update The policies were discussed. These policies will be reviewed at the next Planning Commission Workshop Meeting.
- 14. Stormwater Improvement Project Peter Page Park Gateway Engineers and staff discussed the project. Council requested that the Sherwood/Broad sewers be reviewed and recommendations re-evaluated and a status provided back to Council.
