4. <u>Library Director's Report</u>

5. Police Chief's Report

Chief O'Connor said that in late December, Bethel Park Police Officer participated in Presents From Police with officers from around Allegheny County by visiting Children's Hospital to distribute donated presents to patients. It was very well received.

6. Fire Chief's Report

Fire Chief Dave Gerber gave the fire report for the month of December. He also gave a recap of calls for the year of 2016 and a breakdown of calls by Ward. He said that from 2007 to 2011, the average amount of calls was 385 per year. From 2012 to the end of 2016, calls increased to an average of 422 per year.

He then gave a safety report on using space heaters and advised residents that space heaters are the leading cause of home fire death every year. He suggested to never use an extension cord when using a space heater because they overheat. Keep everything three feet away from the heating unit.

At this time, Chief Gerber introduced Dan Duff, Bethel Park Community Foundation President. Mr. Duff said that the Community Foundation is a non-profit organization and gives out money and various grants throughout the community. Last year, 23 grants totaling over \$60,000 and \$8,600 in scholarships to local students were awarded. Mr. Duff said that the Fire Company approached them about a great idea in technology.

Chief Gerber said that with this check of \$6,500, they can purchase ten IPads to use in the fire vehicles to run a computer program called Active 911 that contains a great deal of information. Previously, computers were used that cost the department over \$35,000. The new technology is much greater.

Mr. Duff said that last year, they were able to assist in helping the community, recreation, fine arts, community safety, Eagle Scouts and the library. He said if you know anyone who the Community Foundation can assist, please let him know.

Mr. Moury thanked the Foundation for their generous donation to the Fire Company.

Mr. Duff said that the trustees of the foundation worked with the Police Department with the Ben Roethlisberger Foundation which help the department to obtain Jeez, the new Canine Officer. The trustees decided to name Jeez as a new trustee for the Foundation.

Chief Gerber thanked the Community Foundation for all the help they provided the fire company this past year. It is greatly appreciated.

"I want to make a couple of comments. In our mail we that got the Thursday before that meeting, we had the contract that was signed by Mr. Spagnol, the manager, and by Mr. Moury, the Council President and the representative of the (unintelligible) and I just object to that type of business. It didn't do any big harm but it doesn't show respect for proper operation. Having said all that, I get, use whatever term you want to, chastised or whatever, because I speak to these issues. I just want to let you know that this year is so-called local elections of five council seats up on the ballot, 1, 3, 5, 7, 9, and I represent 5 and I just want to make sure that the fifth ward public understands that I'll continue to operate in the same fashion that I have been doing and let them be the judge."
