 - Proposed Zoning Ordinance Amendment Signs and Billboards

- Proposed Zoning Ordinance Amendment – Care Facilities and Senior Housing Types, Rehabilitation Facilities, Wireless Communication Facilities, Administration and Enforcement, and Zoning Hearing Board.

The Municipal Planner noted this language will be updated as part of the entire comprehensive Zoning Ordinance update instead of a separate amendment. It was noted that other amendments are a priority and due to time restrictions, it would be more feasible to work the amendment into the comprehensive update.

- Proposed Zoning Ordinance Amendment - Short Term Rentals

Planning & Zoning Commission members reviewed draft language prepared by Mackin Engineering Co. and the previous Municipal Planner to discuss potential regulations. The Municipal Planner provided additional language that was compiled to outline specific topics that relate to the regulation of short term rentals. Mr. Raeder stated that the Proposed Short Term Rental Zoning Ordinance Amendment will be continued at the May 25th Workshop Meeting for further review and discussion.

Proposed Sidewalk Policy

Mr. Raeder stated that the Proposed Sidewalk Policy will be continued at the May 25th Workshop Meeting for further review and discussion. The Municipal Planner indicated that a finalized draft should be ready to recommend by the June 8th meeting.
